OPEN REQUEST FOR PROPOSALS

United Way of Southeastern Connecticut (UWSECT) Allocations supports a dedicated network of nonprofit organizations in New London County, Connecticut within three of the four impact areas: Healthy Community, Youth Opportunity, and Financial Security.

UWSECT strives to serve community members living below the <u>ALICE</u> (Asset Limited, Income Constrained, Employed) threshold. Partner Program applicants will need to address their commitment to serving ALICE households and alignment to United Way's key Impact Areas.

SCOPE OF AWARD

- United Way anticipates approximately \$1.5 million in available funds and intends to grant awards to approximately 40 programs. There are no minimum or maximum funding request amounts though, do consider the median award amount is approximately \$37,000.
- Partner Programs receive a three-year award commitment though the amounts for Year 2 and 3 may adjust based on United Way's fundraising campaign performance.
- Funds must be used for the awarded program.
- Funds may not be used for: fundraising efforts, advocacy or lobbying, political activism, or sponsorships.

ORGANIZATION ELIGIBILITY

- Must be a non-profit, 501(c)3 Health & Human Service organization. May not have a fiscal sponsor.
- Must have a full-time Executive Director or CEO. May not be a shared role with another organization.
- Organization has an active Board of Directors that meets the requirements of the board-approved bylaws including number of board members and number of meetings.
- Has completed three consecutive years of financial reporting in adherence with State and Federal business requirements.
- Must be aligned with United Way's strategic efforts to support individuals or families that live below the ALICE Threshold.
- Municipalities & Schools (public, private, magnet, charter, and university) are **not** eligible.

PROGRAM ELIGIBILITY

- Programs must have a physical footprint in New London County, Connecticut.
 May be a shared space, utilization of local community space, etc.
- Program has been in existence for the last 3 consecutive years.
- The requested funding amount may not exceed 25% of the program's current year budget.
- The program proposal must choose one (and only one) Impact Area: Healthy Community, Youth Opportunity, and Financial Security.
- The program must align with the Impact Area's Outcomes & Indicators as follows:
 - Track participant count (unduplicated).
 - o Align with at least one "Reach" data point (ie: outcome) from chosen Impact Area.
 - o Align with at least one "Result" data point (ie: indicator) from chosen Impact Area.
- Food access programs are not eligible for Partner Program funding. UWSECT prioritizes significant donor funds for the operation of the Gemma E. Moran United Way / Labor Food Center benefiting 65 programs with no-cost access to food.

CONSIDERSATIONS

- United Way funding does not require an increase or expansion in services. Partner Program funding is intended to stabilize and ensure longevity of existing programs.
- United Way funds programs. A program is defined by having a separate budget within the organization's overall budget if it's not the sole program within the organization.
- Organizations may request funding for up to 3 programs (Separate applications for each).
- New Applicants must submit the three most recent years of financial audits/990s. New applicants are organizations who are not current United Way Partner Programs.

PARTNER PROGRAM APPLICATION & REVIEW PROCESS

UWSECT Partner Program's multi-year funding utilizes an intensive volunteer review process to determine which programs will receive funding for three years.

- 1. STEP 1: Complete the Eligibility Screener & Intent to Apply. Completed online via United Way's "Temelio" grantmaking platform. The screener will determine if both the organization and program meet United Way's eligibility requirements. If eligible, the applicant will then complete a simple Intent to Apply form and select an Info-Session date to attend.
- 2. STEP 2: Attend the Info-Session selected on the Intent to Apply form. Details about both the Admissions and Allocations process will be reviewed at the required in-person meeting. The link to the Admissions Application will be provided following attendance at the Info-Session.
- 3. STEP 3: Submit the Admissions Application. This 2-page application (in Temelio) will provide a summary of both the organization and program for a panel of United Way volunteer reviewers. The volunteer review panel will then make decisions on which applications will be invited to the Allocations Application. Responses by December 1.
- 4. **STEP 4: Allocations Application**. If the Admissions Application is accepted, the applicant will be invited to submit an Allocations Application, the final step in the process where funding amounts are determined. This step in the process includes a more thorough online

application, program budgets, program site-visits, and in-person meetings with directors. The full process will be reviewed at the Info-Session.

AWARDED ORGANIZATION'S COMMITMENT

Adheres to Partner Program Agreement (view document) which includes, but not limited to:

- The organization will run an annual United Way Giving Campaign amongst employees and/or board members.
- Funded Partner Program information is listed and routinely updated on CT 2-1-1 website.
- Submits an annual financial audit and Form 990 for the organization.
- Submits annual program reports and impact stories for the funded program(s).
